

Nomer.IO PRIVACY POLICY

Please note that this policy includes an agreement for confidential personal information.

This Privacy Policy of "Nomer.IO" (hereinafter - the Policy) applies to all information that "Nomer.IO", with the consent of the User, represented by the international group of companies ("NOMERIO") could be given about the Users of the Nomer.IO mobile application while using by them the Nomer.IO mobile application generally, as well as about any of the services, functions, programs, products of the Nomer.IO mobile application. The User's consent to the provision of the personal information given by them in accordance with this Policy within a relationship with one of the persons who are members of an international group of companies ("NOMERIO"), applies to all persons included in this international group.

By submitting the personal information, you, being a subject of the personal data, indefinitely give permission to NOMERIO LTD ("Operator"), located at Geneva Place, Waterfront Drive, P.O. Box 3469, Road Town, Tortola, British Virgin Islands, to commit by the Operator the following actions or set of actions, with the use of automatic means or without the use of such means: collection, recording, accumulation, storage, clarification (update, change), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of the personal information. For the above mentioned purposes the Operator can transmit the personal information within its international group of companies ("NOMERIO"), which are necessary to perform the above mentioned purposes or until such time as you will revoke the consent to their processing. The Operator is entitled to retain the personal information as a whole or specific information solely for the purposes specified by law or lawful purposes necessary for the Operator under the conditions of confidentiality to identify the User. The Operator also has the right to copy the personal information and keep such copies of a certain amount of time.

The Operator may share the information (which may also contain the personal information) in order to protect the Operator, to protect its legal rights and fulfill its legal obligations:

- when responding to the requests, the information received in accordance with applicable law
- if the content posted by the User clearly has signs of illegal/criminal information
- in case of receiving from the User a direction when using the Nomer.IO mobile application for the appropriate dissemination of the information provided by them, as if the execution of the User's direction is not possible without the dissemination of the information.

The Operator also has the right to collect and supplement existing information about the User with the additional information which was provided by other Users of the Nomer.IO mobile application.

If you have already submitted the personal data to the Operator and would like to have this information or part of it to be fixed (changed, added) or deleted from our records or would like to know which of your personal information is used by us, and if you have any questions or concerns regarding the processing of your personal data, you can send an appropriate request in the name of " NOMERIO " to the following address: support@nomer.io.

" NOMERIO" takes the necessary and sufficient technical and organizational measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, and other illegal actions with it performed by the third parties, including by means of coding the information provided, and the Operator has the right to decide where to store the information.

As part of this Policy the personal information means the information that has been made available to the Operator pursuant to the express will of the User, as evidenced by using the Nomer.IO mobile application, as well as using any of the functional elements of the Nomer.IO mobile application:

1. the information about themselves that the User obviously provides by themselves when installing the Nomer.IO mobile application, including the User's personal data.
2. the personal information about themselves that the User obviously provides by themselves when registering (creating an account) or using the Nomer.IO mobile application, including the User's personal data.
3. the data, including a list of contacts stored in the phone book of the User or the sim-card.
4. the data that automatically transmitted to the Nomer.IO mobile application during its use by means of the installed on the User's device software, access time, address of the requested page, information about incoming and outgoing calls from the User's device.
5. the picture of the User (including their photos related logically and (or) with the help of third-party software with the data described in p. 3).
6. the information on the location of the User (if the User provides to the Operator the access to the information about their location).
7. the information contained in the texts of the correspondence between Users within the Nomer.IO mobile application, namely, by using its own built-in-functionality of the Nomer.IO mobile application.

This Policy applies only to the functionality of the Nomer.IO mobile application. The Operator does not control and is not responsible for the services provided by the third parties and products of the third parties, which the User can use by following the hyper-links that are available in the Nomer.IO mobile application. Inside of the mentioned services and products of the User different personal information could be collected and requested, and other actions may also be performed and the User has to give or not to give their consent to such actions within a third-party product or service by themselves.

The Operator by default does not check the accuracy of the personal information provided by the Users, and does not exercise control over their capacity. The consequences of misreporting do not involve responsibility for the Operator.

If the User does not give their consent, the Operator does not collect or analyze the information about the User's movement in space, that is, their geolocation. The Operator respects the security and privacy of the User, any ratings, comments, feedback and evaluation within the Nomer.IO mobile application - it's just the Statistical information about the personal value judgments and subjective evaluations and opinions of other Users of the Nomer.IO mobile application for which each User of the Nomer.IO mobile application is personally responsible.
